## ADDITIONAL TERMS OF SPECIAL PROGRAM OF PRELIMINARY TICKET SALES for the performances of the ballet Nutcracker in the 242<sup>nd</sup> theatre season

To facilitate the purchase of tickets (especially for non-residents of Moscow), tickets unsold during preliminary sales will be sold simultaneously on the official website of the Bolshoi Theatre (<u>www.bolshoi.ru</u>) and at the ticket office in the management building of the theatre, according to the following schedule:

- On October 9, 2017 at 11:00 starts the sale of tickets for the performances from 23 to 28 December, 2017.
- On October 10, 2017 at 11:00 starts the sale of tickets for the performances from 29 to 31 December, 2017.
- On October 11, 2017 at 11:00 starts the sale of tickets for the performances from 2 to 7 January 2018.

Information on the number of tickets for sale can be found on the website and on screens at the ticket office since the opening of ticket sales.

The above tickets will be sold as follows:

1. <u>On the official website of the Bolshoi Theatre (www.bolshoi.ru)</u> tickets can be purchased by a registered user under the rules of online ticket sales. To purchase a ticket the User/Buyer should sign in to the Theatre Website and in his/her private account enter personal data of each viewer - a surname and passport data (birth certificate of a minor child), the ticket system automatically generates a ticket order, which should be paid via a bank card. After the successful completion of the purchase, you need to print the CERTIFICATE and exchange it for the original tickets at the theatre ticket office. RESTRICTION: in any one order there can be no more than 2 (two) tickets.

<u>ATTENTION</u>: CERTIFICATE should be exchanged for original tickets before the beginning of the performance (in any day during the work of the ticket office in the management building of the theatre). The Buyer should present a printed copy of CERTIFICATE to the cashier. The Buyer should to appear in person to exchange a certificate for original tickets. With the certificate, the Buyer needs to present the ORIGINALS of his/her passport and the bank card, through which the purchase of tickets has been done, as well as the passports/ birth certificates of all viewers (at the time of exchange you may present copies) listed in the certificate.

2. At the ticket office of the theatre (in the management building), the above-listed tickets can be purchased only on the documents of the viewers - the passport and/or the birth certificate of the minor child (at the time of purchase the buyer can present copies) for which tickets are purchased. RESTRICTION: an individual can purchase no more than 2 (two) tickets.

**3.** The tickets will be printed on a special form; the data of the viewer's passport (birth certificate of the minor child) will be indicated in the tickets

4. Viewer's documents (passport/birth certificate of the minor child) indicated in the tickets will be mandatory checked at the entrance to the theatre on the day of the performance.

5. A ticket with corrections is invalid; any changes of data in the purchased tickets are not permitted.

6. If a viewer unable to attend a performance, he must personally submit an application specifying the reason and provide a passport (birth certificate of the child) to the theatre ticket office.

<u>ATTENTION</u>: the tickets under the SPECIAL PROGRAM OF PRELIMINARY TICKET SALES can be purchased only on the official website of the Bolshoi Theatre (<u>www.bolshoi.ru</u>) and at the ticket office in the management building of the theatre!
